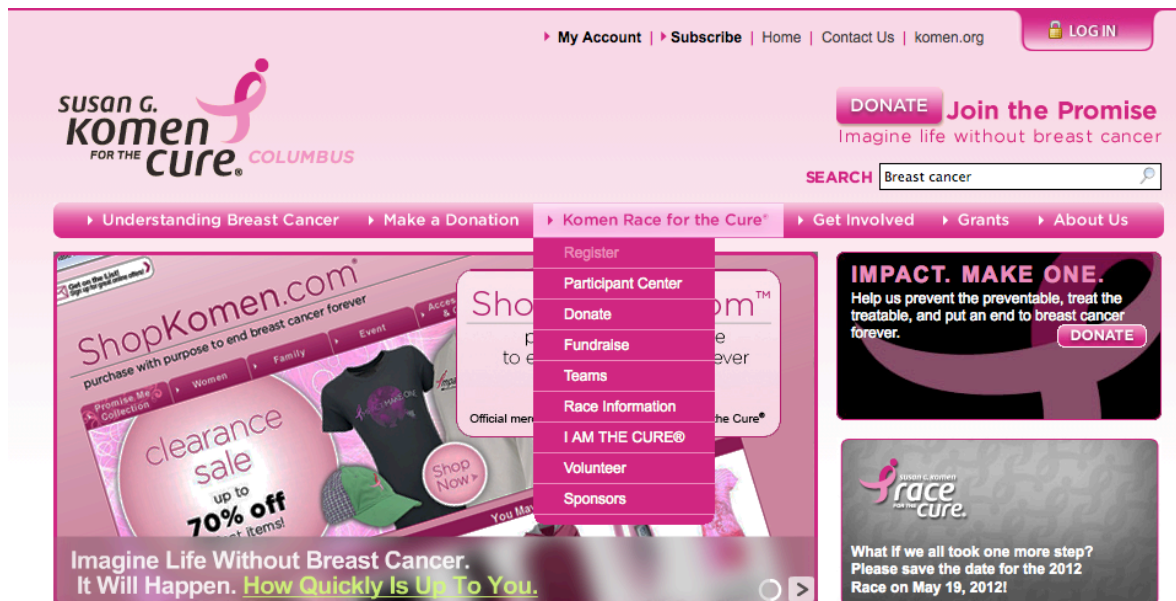


## HOW TO REGISTER AS AN INDIVIDUAL

1. Visit [www.komencolumbus.org](http://www.komencolumbus.org)
2. Roll over the “Komen Race for the Cure” tab and click “Register.”



3. Select “Register as an Individual” in the gray box in the middle of the page.



4. Select “Adult Individual Participant” or “Child Individual Participant”, make an additional gift if you’d like (**this will not apply to your personal fundraising page**) and set your fundraising goal. You may also opt to have your

Race t-shirt and packet mailed to your home in late April or early May (*since you are participating as an individual and not as part of a team*), or purchase a timing chip to be competitively timed in the 5K run for an additional \$5.
